This document reflects the work performed by the Frances Baard District Municipality for the 2020/2021 financial year.

It outlines the key projects for the district municipality, with specific emphasis on infrastructure, environmental health, disaster management, firefighting, housing, local economic development, tourism, spatial planning and geographic information systems (GIS).

Operation and Maintenance (O&M)

Funding to the value of R10m was allocated for the operation and maintenance programme for the 2020/21 financial year. In January 2021, Council approved a further R6,5m towards O&M projects, bringing the total to R16.5m for the 2020/21 financial year. Dikgatlong, Magareng and Phokwane received R1,5 million each and Sol Plaatje an additional R2 million. The following is a summary of the expenditure on operation and maintenance projects and activities:

Rural Roads Asset Management System

The purpose of the grant as stated in the Division of Revenue Act (DORA) is to assist municipalities in setting up their rural road asset management systems. Through this programme, the extent and condition of all municipal streets are determined and reported to be used for planning for upgrading, refurbishment and maintenance of roads. The road and traffic data are collected in line with the Road Infrastructure Strategic Framework for South Africa (RISFSA). For the 2020/21 financial year, the district municipality received an allocation of R2,5m for the implementation of the RRAMS in the district.

Expanded Public Works Programme (EPWP)

We received an EPWP incentive grant of R1,1m from the Department of Public Works & Infrastructure for the 2020/21 financial year. The incentive grant agreement was conditionally granted based on the minimum of 14 full time equivalents (FTE) and a planned 50 work opportunities are created. All 50 of the work opportunities were created amounting to an FTE score of 30.17 (215,47% over-achievement). The following projects were implemented within the district:

Youth Entrepreneurship Development Programme (YEDP)

This programme is meant to capacitate youth graduates in career development and additionally offer workplace experience and enhance professionalism. This is an ongoing programme and we currently employ a total of 11 graduate interns in the sections, Local Economic Development (LED), Performance Management Systems (PMS) and Tourism for the 2020/21 financial year. Graduates are delegated supervised work-related tasks which improve workflow of the municipality and gain competency in carrying out tasks. To date the YEDP has generated 19 work opportunities, which translates into 9.56 FTE points achieved for the 2020/21 financial year.

Operation and maintenance of municipal amenities - Magareng Local Municipality

The works performed on this project include the maintenance of roads and stormwater structures within the road reserve including, grass cutting, fencing, cleaning/clearing of blocked stormwater structures, clearing of the vacuum sewer system, and general cleaning and clearing of municipal cemetery using labour intensive work methods. A total of 21 work opportunities was created, amounting to a FTE score of 16.03.

Operation and maintenance of municipal amenities - Dikgatlong Local Municipality

This project includes works in the maintenance of basic infrastructure services, including water reticulation, sanitation and dams, bolder and rock removal and clearing of illegal dumping sites

using manual labour as well as other municipal amenities. The project is based in Dikgatlong Local Municipality, and the commencement was delayed due to community unrest. This project commenced on 18 January 2021. Currently this project employs 10 EPWP participants creating a total of 4.57 FTEs and generating a total expenditure of R 102 215.00, which is 34.07% of the total budget. The under expenditure is due to delayed start of the project and the remaining funds was used with the two remaining projects.

Housing

Human Settlement Sector Plans (HSSP)

We did not to review the HSSP for the 2020/21 financial year as the plan for 2019/20 was only approved in June 2020 and was not yet fully implemented. The Covid-19 lockdown has presented some challenges.

Subsidy Administration

No subsidy administration has been taking place due to an IT problem that caused connection problems. This meant that the HSS forms could not be captured on the server. COGHSTA has in the meantime captured the forms on another server and will arrange for training to be provided to administrators using the new route of capturing. The roll-out of the training has unfortunately been delayed due to Covid-19.

Environmental Health

Municipal health services at local municipalities

The district municipality renders municipal health services (MHS) in three of the local municipalities, namely Phokwane, Magareng and Dikgatlong. The municipality has entered into an MOU with Sol Plaatje Municipality in order for the local municipality to render MHS in its area of jurisdiction on behalf of FBDM. The appointment of an adequate number of Environmental Health Practitioners (EHPs) remains a challenge, as the National Environmental Health Norms and Standards prescribes a ration of 1: 10 000.

Combating Covid-19 pandemic

The Covid-19 pandemic is having a devastating effect on human health and the economy globally. The municipality responded to the call of the President that municipalities must implement measures to mitigate the spread of the virus. The municipality have procured protective clothing for the emergency and front-line workers who were involved in the decontamination of public spaces, taxi-ranks, hospitals, clinics and offices of sector departments. Facial masks, antibacterial soap and sanitisers were also distributed to vulnerable communities in the district. The municipality allocated R1m to the fight against the pandemic, of which R337,292 was spent in the 2020/21 financial year.

Awareness campaigns

Various awareness campaigns were held in the district to sensitise the communities on the symptoms and preventative measures to curb the spread of the virus. We continue to put emphasis on the importance of wearing facial masks, practicing social distancing and washing and sanitising of hands. Communities are also trained on how to wash their hands effectively with water and soap. The Department of Water and Sanitation also installed storage tanks in the communities which were daily filled with clean drinking water. Antibacterial soap and sanitisers were also distributed amongst the communities to curb the spread of the virus.

Disaster management and firefighting

Contingency Fund

An amount of R633,316 was spent from the contingency fund to assist destitute families within the Phokwane, Magareng and Dikgatlong local municipalities for the financial year. The contingency fund expenditure incurred per local municipality for the year is as follows:

Volunteer training

No training took place, however, meetings were held with the disaster management volunteers three local municipalities, namely Dikgatlong, Magareng and Phokwane. The purpose of the meetings were to update the volunteers on identified risks and to update their Level 1 and Level 3 First Aid training.

The establishment of a satelite fire station in the Phokwane local area

A service provider was appointed to design the fire engine bays at Jan Kempdorp. Final designed sketches were submitted before the architects could finalise the plans, which must be submitted the Phokwane Municipality for approval. The service provider prepared the tender documents for the project. It is planned that the construction phase will commence in January 2022.

Review of the District Disaster Management Plan and framework

A service provider was appointed to review the District Disaster Management Plan and Framework, and Disaster Management Plan for the Dikgatlong Local Municipality. The project was successfully completed. The process included the following steps

- Consultation process with community members.
- · Community based risk assessment.
- Current reality assessment, risk, vulnerability and hazards.
- Review of the District Disaster Management Framework; and
- Develop climates change adaptation strategies.

Local Economic Development

SMME Capacitation Programme

Small enterprises are underdeveloped and appropriate support is needed so that these enterprises can play a larger role in the economic activity of the district. Despite SMME funding and access to finance as major hindrances to their development, they also suffer from poor business and management skills which are a result of lack of adequate training and education which has resulted in a high rate of business failures. To address this challenge the district municipality embarked on a series of SMME skills training and support services interventions aimed at addressing the underlying factors that affect the growth and development of local SMMEs. One such programme is the skills training and early stage support for identified SMMEs operating within the Frances Baard District Municipality. The programme was aimed at responding to the specific needs of SMEs combined with coaching and mentorship programmes.

Entrepreneurship Week

The Frances Baard District Municipality (FBDM) and its local municipalities hosted the annual Small Business Week from 16 - 20 November 2020. The entrepreneurship week serves as a platform to reflect on the state of entrepreneurship in the district and to encourage entrepreneurship, especially among our young people. The district municipality has identified the need to provide opportunities for small businesses to access available opportunities, hence the creation of the Small Business Week to coincide with the Global Entrepreneurship Week.

Machinery and Equipment Grant

The purpose of the machinery and equipment grant is to support small businesses with machinery and equipment that can improve their business productivity and efficiency. The grant is an initiative by the municipality to develop enterprises by improving their efficiency and productivity. the district municipality handed over machinery and equipment to the eight SMMEs who met all the requirements of the Machinery and Equipment Support Grant. The district municipality received more than 290 applications.

Tourism

N12 promotion

The annual N12 promotion campaign was hosted in partnership with NCTA and Magareng Municipality from 16 – 18 December at the Phumla petrol station (Warrenton) and Shell Ultra City (Kimberley).

The campaign was launched in 2013 to encourage summer holiday visitors to travel via the Northern

Cape Province en-route to their travel destinations and to create awareness of the tourism products on offer along the N12 national road.




Spatial Planning

District Municipal Planning Tribunal

In the 2020/21 financial year the tribunal received and processed 24 land development applications for Magareng, Dikgatlong and Phokwane local municipalities. The DMPT is operational without any challenges.

Phokwane Infill Development

The district municipality is assisted Phokwane local municipality with infill development on erven 51280 and 21950 in Valspan, Jan Kempdorp. The project involved closure of the public open space, subdivision, re-zoning, and a cadastral survey of 39 erven. The approval by the District Municipal Planning Tribunal (DMPT) and submission to the Surveyor-General for approval and registration will be concluded

in the 2021/22 financial year. The delay in appointment of the environmentalist by Phokwane Municipality delayed the project.

Frances Baard District Municipality Spatial Development Framework (SDF) review

The district municipality completed the review process of the 2014 spatial development framework in compliance with the provisions of the Spatial Planning and Land Use Management Act (SPLUMA) 2013, Municipal System Act of 2000 and the Department of Agriculture Land Reform and Rural Development (DALRRD) SDF Guidelines of 2017. The spatial development framework is a policy framework that guides the desired spatial form, spatial direction for the development and land use management within the district.

The district municipality assisted Magareng local municipality with the review of its 2014 spatial development framework. The project was partly completed and will be finalised in the second quarter of the 2021/22 financial year.

Land Use Survey for Dikgatlong Municipality


This project was initially planned for implementation in the 2019/20 financial year but due to delays in the appointment of a service provider, as a result of the Covid-19 pandemic, implementation was only accomplished in the 2020/21 financial year. Through the project certain elements of the scheme was assessed which were not covered in the original study. The project was successfully completed with all deliverables and reports received. The budget for the project was R390,000.




An illustration of erf boundary discrepancies flagged that cuts through the building structures.

Land Audit and cadastral update for Frances Baard District

In order for local municipalities to effectively perform their municipal functions they need to have access to a spatial register of all properties that lie within their municipal area. The spatial register is populated by conducting a land audit to create cadastral datasets and an updated property ownership list. The district municipality conducted the land audit and cadastral updates to establish land ownership and to determine whether disposed properties have been properly transferred. The land audit was completed to schedule and all deliverables together with the close-out report was received. The budget for the project was R500,000.
